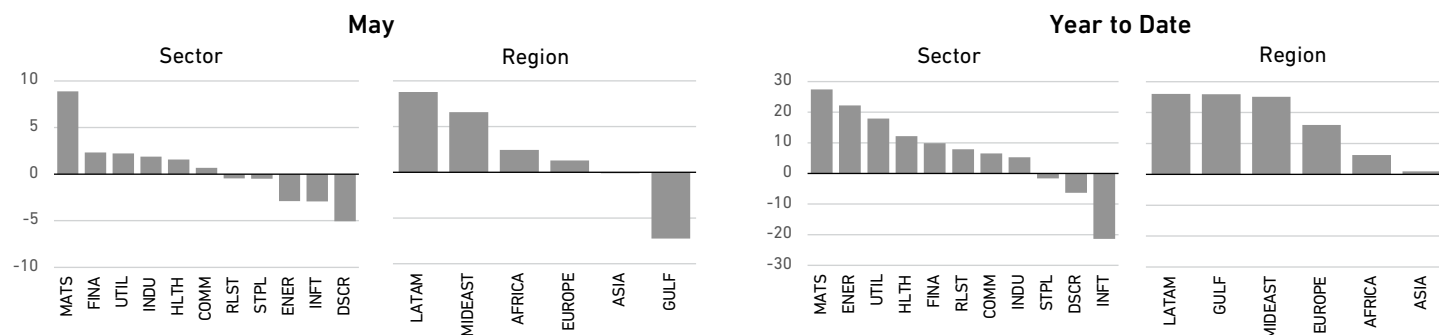

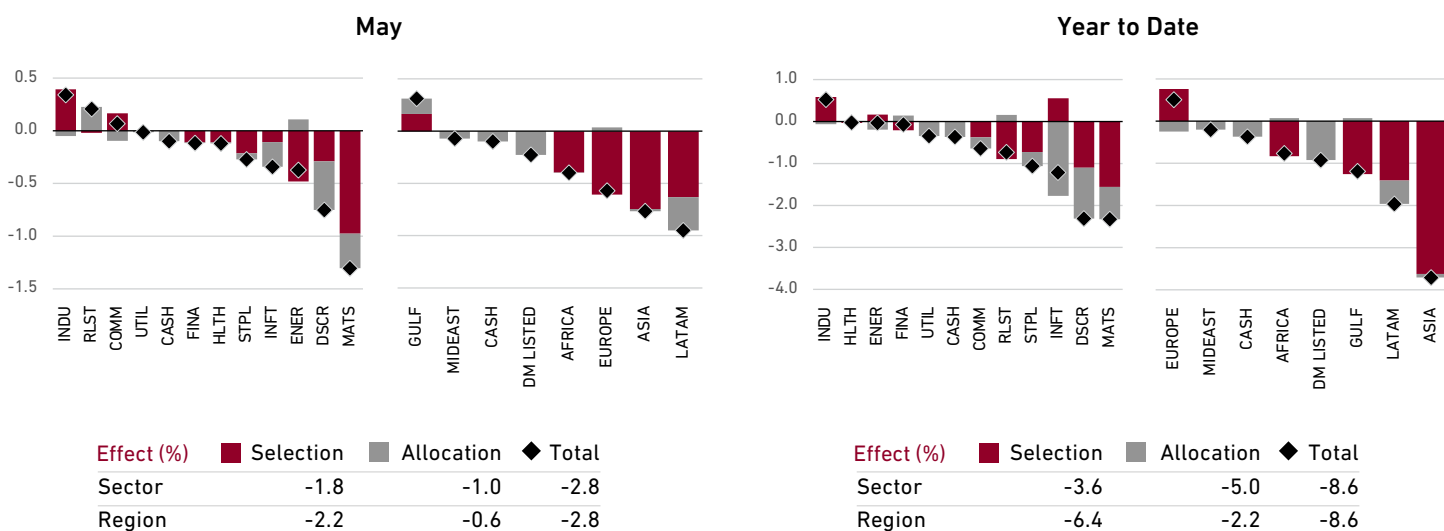
Index Performance (USD %)
